

The Vial Adapter[™] transfer device is a single-use, sterile, medical device intended for the transfer of drugs contained in a vial. Puncturing the elastomeric closure of a vial is achieved by means of an integral plastic spike located in the center of the vial adapter. The device plastic package and cover are designed to limit direct contact, reduce potential for contamination, and to assist in attaching the device to the drug vial.

VENTED VIAL ADAPTER[™] TRANSFER DEVICES

- One piercing spike with two lumens:
 - One for transfer of drug/solution between the drug vial and a syringe
 - Second for enabling pressure equilibrium of the vial by introducing air that has passed through a 0.2 micron hydrophobic air filter into the vial.

SWABABLE VIAL ADAPTER[™] TRANSFER DEVICES

• Consists of the vial adapter body with a single lumen piercing spike and a swabable valve which allows multiple needle-free accesses to drug vial to facilitate withdrawal of medication for treatment.
